The Lohmann & Birkner GmbH will give you an internet voucher to access the guest Wi-Fi service. On this voucher you will find a username and password to access the Wi-Fi service. Only guests who accept and sign the following agreement will receive a voucher.

The use of the Wi-Fi service is free and limited to the guest's period of presence in the area of the Lohmann & Birkner GmbH. The Lohmann & Birkner GmbH does not guarantee any specific transmission speed, data transmission rate, and/or uninterrupted transmission. Furthermore, the Lohmann & Birkner GmbH shall not be liable for disruptions in the data connection. Usage of the Wi-Fi service is at your own risk.

You understand that the Lohmann & Birkner GmbH guest Wi-Fi service, which utilizes wireless technologies, is not inherently secure and that wireless communications can be intercepted by technology designed and intended for that purpose. We will not be liable to you or any other party for any lack of security that may result from your use of the Lohmann & Birkner GmbH guest Wi-Fi.

You agree that you are responsible for providing security measures (e. g. firewall, virus protection) that are suited for your intended use of the Lohmann & Birkner GmbH guest Wi-Fi. For example, you shall take full responsibility for taking adequate measures for safeguarding your data from loss.

We reserve the right to modify the Lohmann & Birkner GmbH guest Wi-Fi service and these Terms and Conditions of Service and any accompanying policies, for any reason, and without notice, including the right to terminate the service with or without notice. The Lohmann & Birkner GmbH reserves the right to terminate your access to the Lohmann & Birkner GmbH guest Wi-Fi service immediately and without notice at its sole discretion.

We have the right, but not the obligation to monitor, intercept and disclose any transmissions over or using our Wi-Fi service, and to access, provide, and disclose your demographic account information and related information under certain circumstances (for example, in response to lawful process, orders, subpoenas, or warrants, or to protect our rights, users or property).

You understand that the use of the Wi-Fi access voucher is limited to your personal use and your period of presence at the Lohmann & Birkner GmbH. You must keep secret your username and password. It is not allowed to share your Wi-Fi access voucher with anybody else.

Using the Lohmann & Birkner GmbH guest Wi-Fi service obliged to adhere all German laws.

- To transmit any material (by uploading, posting, email or otherwise) that is unlawful, threatening, abusive, harassing, tortious, defamatory, obscene, libelous, invasive of another's privacy, hateful or racially, ethnically or otherwise objectionable.
- For the transfer of technology, software or other materials in violation of applicable export laws and regulations, including but not limited to the German Administration Regulations and Executive Orders.
- For the distribution of any Internet viruses, worms, pinging, flooding, mail bombing, denial of service attacks, defects, Trojan horses or other items of a destructive nature.
- To transmit (by uploading, posting, email or otherwise) any unsolicited or unauthorized advertising, promotional materials, "junk mail," "spam," "chain letters," "pyramid schemes" or any other form of solicitation.
- For accessing sites with illegal content and distributing illegal or legally protected content.
- To violate intentionally or unintentionally any applicable local, state, national or international law, or any regulations having the force of law;
